Ladies and Gentlemen:

1. I am authorized to sign this affidavit on behalf of _____
("Sponsor/Advertiser").
2. Sponsor/ Advertiser operates the following website _____(the "Website") in the State of _____ (the "Licensed State").
3. Sponsor/Advertiser has a valid license from the Licensed State to operate the Website, and a copy of such license is attached hereto as Exhibit A.
4. The Website and the tournament and games contained therein (if any) and any advertising for the Website and associated tournament and games complies with all laws, rules and regulations, including, without limitation, all Licensed State laws, rules and regulations covering gambling and real money gaming websites.
5. Sponsor/Advertiser has major operational or marketing agreements in place regarding the Website with the following companies in the Licensed State:

6. The Website does not allow deposits or registrations from anyone under the age of 21 and Sponsor/Advertiser takes appropriate measures to prevent anyone under the age of 21 from registering on the Website or making a deposit on the Website.
7. The Website does not allow deposits or registrations from anyone accessing the Website outside of the Licensed State, and employs geo-filtering to prevent anyone accessing the Website outside of the Licensed State from registering on the Website or making a deposit on the Website.
8. The Website, including all of its pages, games, and other components, contains no links or references whatsoever to any websites that allow deposits from residents of the United States located in states other than the Licensed State.
9. The Website does not use any "popup," "adware," "spyware" or similar software for the purpose of directing visitors to any online gambling websites that allow deposits from residents of the United States located in states that have not regulated real money gaming or states where Sponsor/Advertiser does not hold a license.
10. The Website does not conduct any cross-promotional, advertising or marketing activities with any online gambling websites that allow deposits from residents of the United States located in states that have not regulated real money gaming or states where Sponsor/Advertiser does not hold a license.
11. Any advertisements run by the Sponsor/Advertiser will include a clear and conspicuous disclosure that the Website is only available to persons accessing the Website from the Licensed State, and is for persons at least 21 and older.

12. Sponsor/Advertiser will immediately notify WPTE if there are any changes to the Website or Sponsor/Advertiser's business that would make any of the declarations contained herein untrue in any way.
13. There are currently no claims or investigations by law enforcement officials, regulators or other governmental authorities in connection with the business activities of the Sponsor/Advertiser or any of its employees. If, during the period in which the Sponsor/Advertiser is involved with WPT Enterprises ("WPTE"), the Sponsor/Advertiser learns of any such investigation or claim, the Sponsor/Advertiser will immediately notify WPTE.
14. Sponsor/Advertiser will defend, indemnify and hold WPTE and WPTE's parent, subsidiary and affiliated companies (including, without limitation, the broadcasters) and the directors, officers, employees and agents of each, harmless from and against any and all third party claims, damages, liabilities, costs and expenses, including but not limited to reasonable attorneys' fees and expenses, arising from or relating to any alleged or actual breach of Sponsor/Advertiser's declarations, obligations, covenants, agreements, warranties or representations hereunder.
